Ms. Shaw will be working to provide better access to the County's historical records by utilizing the Records Center web page. Ron Clayton will be her IT contact. Family Search will be scanning the Commissioner's Journals and Probate records. The service will allow the County to receive the scanned images for the web site, free of charge. Links will be included on the web page that will provide access to Family Search scans completed in prior years.

#### **Scanning Services**

Marion County Clerk Jessica Wallace and staff Jada Husbands and Brandy Gandert, Recorder Debra Miller and Serenity Linstedt, Chief Deputy for Family Court (Juvenile and Probate Courts) toured the Records Center on April 7<sup>th</sup>. Upon seeing the Center's operations, Ms. Shaw was ask if the Center could assume the scanning and preservation services for Marion Clerk of Courts and Probate Court. Ms. Shaw stated she would take the request before the April 13<sup>th</sup> Records Commission meeting. After some discussion, the Commission decided that the Records Center was not in a position to take on the services for Marion County. Ms. Shaw is to notify Marion County of the Records Commission decision. When notifying Marion County, Clerk Fravel requested that her consultation services be extended with that of the Records Center.
