Any Other Matters of Concern for the Records Commission

Ms. Shaw spoke on the progress of HB139. HB139 is an initiative lead by the CARMA Legislative Committee. The bill would amend part of the Ohio Revised Code. This amendment would allow access to previously closed historical records that are over 100 years old. Examples of these records would include adoptions, lunacy records, county home registers, children's home registers, and veteran's relief records.

Ms. Shaw provided an update on the Archives Crawl, a Records Center outreach event. The event is held in conjunction with National Archives month. The October occasion includes 13 repositories eager to show case their facility and educate crawlers on the history they maintain.

Mr. Kaitsa commented on a job well done regarding the Ohio Electronic Records Workshop held on October 6th. The workshop was hosted by the Records Center. The Ohio Electronic Records Committee (OERC) presented two sessions. Each session included tours of the Records Center and an explanation of the Center's operations. Ms. Fravel commented that the Clerk from Morrow County attended a session and was impressed with the training and the Records Center.
